

Educators Program Copying Agreement

This Educational Program Copying Agreement is made and entered as of _____ (date) and will expire _____ (date), between Balsynd, LLC dba Elie's Spiritual Treasures, located in Victoria, Texas (Licensor), and _____ (Licensee), for the facility named _____ located in _____.

Licensor owns the copyright, title and all other related rights to the books titled "Elie's Spiritual Treasures Bible Word Search" (Work) and has the right to license others to copy material from certain books of said Work for educational purposes.

Licensee desires to obtain, and Licensor has agreed to grant, copying of the Work by Licensee in accordance with the terms and conditions of this Agreement.

Licensor hereby grants to Licensee, an exclusive, non-transferrable copying agreement to use the Work for the licensed period for the facility named and to otherwise copy and use part of the Work for educational purposes only.

Licensee acknowledges that Licensor is the sole owner of the Work and of all associated U.S. copyright registrations related to such work, and Licensee shall do nothing to interfere with such ownership. Licensee agrees that nothing in this Agreement shall give Licensee any right, title, or interest in the Work other than the copying right to same in accordance with this Agreement. Such Licensee right on copying shall be evidenced by the Work being stamped with the design attached as Exhibit "A" which will notate the Agreement Number and expiration date of same.

The unauthorized use or distribution of the Work or any part thereof is illegal and could subject the user to substantial monetary damages and attorney fees. Licensee will be liable for any damage and attorney fees associated therewith resulting from any violation of this Agreement, including any infringement of copyrights or other proprietary rights.

This agreement shall commence as of the Effective Date and shall continue until the expiration date and shall automatically renew for additional one (1) year periods, unless either party provides written notice of non-renewal to the other party, not less than sixty (60) days prior to the expiration date of the Agreement.

Licensor does not guarantee that the information in the Work is error-free nor warrants that the Work will meet Licensee's requirements for education or curriculum.

The Specific Work that is subject to this Agreement shall consist of _____ (Specific Work).
